




# PARISH COUNCIL NEWS

#### **Oxford Flood Alleviation Scheme**

The Environment Agency, and others, have been working on proposals for a scheme to reduce significant flood risk to residents and businesses in Oxford. This includes a new flood relief channel. The Environment Agency will give a brief presentation about the scheme to the Parish Council at the next Council meeting on 1<sup>st</sup> September.

#### Oxfordshire County Council – Subsidised Buses and Dial a Ride consultation

The County Council needs to save money on supported transport services. A consultation which ends on 14<sup>th</sup> September is taking place. As part of the cut backs, the village no longer has the benefit of the subsidised evening and Sunday services. If you were a bus user at these times, then please let your local councillor know, as the matter is likely to be discussed at the next Parish Council meeting.

#### Oxfordshire County Council – Minerals and Waste Core Strategy

The Minerals and Waste Local Plan part I Core Strategy has recently been published and the County Council is inviting comments on the Plan before it is submitted for examination to the Secretary of State. #### Sunday Trading Hours – possible changes

The Government has put forward proposals to devolve Sunday trading laws locally, to give greater flexibility so that large shops can stay open longer. The Vale of White Horse District Council before responding, wishes to seek the views of residents in the Vale. #### July Meeting of Parish Council

At the July meeting of the Parish Council, developers Redow and Pye from Milton Road sites spoke to the Council regarding drainage from their sites at the Southern end of the village. The Council is aware that there is a possible breach of planning condition in that some of the houses are being occupied and there are outstanding issues regarding drainage. The Parish Council has agreed to attend a meeting, with all parties to discuss an effective solution to the drainage issues in the village.

#### Vale of White Horse District Council – flood grants

The District Council has available funding to alleviate flooding. It is understood that few people have lodged applications. If you have been affected in the past, and require to undertake measures to try and prevent flooding in the future, then contact the Vale of White Horse District Council.

# PARISH COUNCIL NEWS

### **Planning Applications**

The following planning applications have been considered :

P15/V1304/O Redevelopment of Didcot A site. The Council objected to the application as submitted, as traffic studies did not take into account other approved applications, such as the warehouse in Sutton Courtenay Lane, nor the impact on through traffic in the village, as well as pedestrian routes, and industrial operations at the site being in conflict with the Science Vale proposals.

What is currently proposed for the site is for mixed development including up to 400 dwellings, 110,000 sq.m. of general industrial/storage use, 25,000 sq.m. of light business use, retails units, hotel and pub/restaurant., open spaces, and reserving land for a new science bridge. P15/V1497/HH First floor and rear extension at 4 The Nursery. The Parish Council had no objection.

P15/V1530/HH 2 dormer windows to roof space. 52d Tyrrells Way. The Parish Council objected as the proposal was to also include an additional bedroom as well, and a previous similar application had been refused. The required additional parking would result in loss of amenity space.

P15/V1721/HH First floor office extension at The House, All Saints Lane. The Council objected. The proposal showed a scheme which seemed inconsistent with residential use and concerns were raised regarding business use, and the impact on traffic in the area.

In addition to the planning applications, Hansons have enquired of the County Council as to whether an environmental impact assessment is necessary should they submit an application for a concrete batching plant on their land which forms part of the overall landfill site.

# SUTTON COURTENAY PRIMARY SCHOOL

When you read this we will be starting our new school year, welcoming in a large class of Reception children and a number of other new children who have moved into the village. The school has grown from only 80 children when I started, to the current number of 144 and is set to grow further.

Prior to the holidays, I met with the Architect who will be planning the school extension. This is a very exciting time for the school and we are looking forward to seeing the plans that the Architect has been putting together over the summer term.



Sutton Courtenay C of E Primary School is very fortunate to have very large

grounds which will mean that the two extra classrooms that are going to be built will hardly affect the amount of play space. In addition, the run down temporary building that was used as the Family Centre will have been removed over the summer holidays, providing even more space for our pupils to play during break time and lunchtime!

Over the last six years the whole school has been redecorated and modernised which has enabled us to offer even more to our pupils than ever before. Due to the Wi-Fi network in place, iPads and laptops are used throughout the school with all year groups; Forest School sessions are able to take place within the school grounds due to our developing area (as well as being able to use SCEEC). This year our Caretaker, Mr Greenough, has built and nurtured a wonderful allotment area with the children. Lettuces have already been used for the salad option at lunchtime and much more of the crop will be ready as you read this.

The two new classrooms are due to be ready by June 2017 and we expect pupil numbers to continue to grow while we are waiting for them to be completed.

If you do have children that are about to be three years old, or are looking for a school place for your child to start school in September 2016, please do make an appointment to come and visit the school. Our website *www.suttoncourtenayprimary.co.uk* has a lot of information on it too, but a visit will enable you to really get a feel of our school and the special ethos that we have within it.

### **REST IN PEACE**

We send our condolences and the assurance of our prayers to the family and friends of the following people who have died recently:

Vince Collier who died, aged 36, on 4th June 2015 was born on 8th December 1978 in the JR Hospital. He grew up as the much loved baby of the family with his two older sisters - Kym and Lisa - and their parents Lyn & Dave in their home in Sutton Courtenay. He was the apple of his mother's eye - and she adored him. When he was about three years old he watched the film 'Tarzan' and for a long time he refused to answer to the name Vince but just wanted to be called 'Boy'! He had a great sense of adventure from an early age and had learnt to ride his pushbike without stabilisers by the time he was three. It was hard to stop him escaping from the garden and one day Lyn remembers hearing him shouting and came out to find him hanging by his trousers from the gate which he had been trying to climb over. The family also remember his determination never to give up but to keep on trying when he was on Wittenham Clumps and wanted to ride a tea tray all the way to the bottom but standing up. His drive for perfection meant that he simply kept on trying until he did it! To his sisters he might well have been an annoying little brother but it is obvious that they both loved him deeply. They also remember him being like a little magpie – and apparently this didn't change as he grew older. He was always 'borrowing' things! Growing up he was close to his Grandad Tony and he loved the River and fishing and simply being out of doors. His great passion was for metal detecting which became an all-consuming hobby. He was determined that one day he would find treasure. Vince and his Dad shared a love of Motor Cross and they would travel to events all over the place so that Vince could compete. There was one memorable meeting when, taking his Dad's advice, Vince had put on a pair of tights under his jeans to keep himself warm. Unfortunately that day he had an accident and had to go in an ambulance to be given a check-up. No-one could understand why Vince kept on refusing to let the ambulance staff remove his jeans - until he managed to tell his Dad it was because the tights he had put on that morning were borrowed from Lisa – and not only that but they were her bright pink ballet tights! Vince was so embarrassed and did not want to ruin his street cred and macho image! Vince went to Sutton Courtenay School before going to John Mason in Abingdon. On leaving school he did a variety of jobs from signwriting to working for Viking Tyres until he eventually became a hod carrier. He was physically very fit and strong and was proud of his ability to work hard and fast and be the best he could be. He met Angie at a pub and their friendship developed into a deeply loving relationship over time. He had no hesitation in becoming step-father to her children showing them unconditional love and acceptance. He also adored his nieces and nephews and relished his role as 'Uncle'. Sadly Vince started drinking in his late teens to give himself confidence and boost his self-esteem and eventually alcohol overpowered him and he became an alcoholic. He tried several times over the years to quit and showed real grit and determination to do so. He knew that it was ruining his life and affecting the lives of all those he loved and he struggled over many years. It is a testament to his efforts that he managed to go 18 months clear of alcohol before his last relapse. But we should not let this disease define our memories of Vince. From talking with Angie and the family I know that you all share many happy and positive memories of his life too. I know that he was loyal to his real friends and fiercely protective of his family. He was a man who was deep and thoughtful, caring and loving, soft and gentle. And this is the man we remember and celebrate today and who will be greatly missed by all his family and friends. This is an edited extract from the address given by the Reverend Helen Kendrick at Vince's funeral, which was held in All Saints' Church on 17th June 2015.

Jasmine Hornsey who died, aged 71, on 24<sup>th</sup> July 2015 was born on 26 May 1944 – the youngest child in a family of six and she and her twin brother, Peter, grew up in Surrey where they attended the local prep school. From an early age her bright intellect shone through as she was the only one in the family who always came top in exams, and she positively relished taking them. Although she wanted to be a Doctor, the opportunities weren't there, and so she went onto do nursing training at St Georges and specialized in midwifery when she would trundle around on a bicycle. She eventually left the NHS to be a private nurse in corporate companies. And it was whilst working in this field that she met Terry, whom she married in 1987 and they moved to their brand new house in the Nursery in Sutton Courtenay. Sadly Terry died 17 years ago but Jasmine, with grit and determination, went onto rebuild her life. Her love of studying and hard work continued throughout out her life as she went onto take a Law Degree through the Open University and set up her own company – Oxford Health Works - specializing in Occupational Health issues and in recent years she studied yet again to become a specialist in mediation. She was always very hard working, incredibly well-organised and efficient at whatever she turned her hand to. A loyal and faithful worshipper at All Saints' she was a stalwart of our rotas - taking her turn at reading the Bible and serving at Communion. She was on the Parochial Church Council for many years and served as Churchwarden. She was an enthusiastic participant in the annual Oxfordshire Historic Churches Trust Bike Ride and she was a key figure on our Church Building Project until her illness forced her to step down. ### **REST IN PEACE**

Friendly, social and hospitable - she was well known for her 'Open House' parties. She protested that she was not much of a cook and that Terry was the expert but she always managed to produce delicious food! Jasmine was also devoted to cats - both her own and those belonging to other people. She was always very generous, thoughtful and helpful and made a good neighbour. She had a keen spirit of adventure – enjoying sailing and learning to windsurf at an age most people have already given up! She loved to travel all over the world and was very generous in taking members of the family on holiday with her. She was a voracious reader – and she was one of the founding member of a long running village book club. Jasmine had the skill of picking books which were challenging and thought-provoking but most importantly which everyone in the group enjoyed – something not all of us manage! She was funny and clever and had a gift for making astute, literary comments. She was a positive, faith-filled woman with courage and a great love of life. She was someone with a fierce intellect and knowledgeable about many things and keen to embrace new technology. She had a wry sense of humour and a great sense of fun. She was kind and considerate and generous with her time and money. Above all she was modest and unassuming, calm and seemingly unflappable and didn't like a fuss to be made. Jasmine strived to make the most of life as she found it. And the way she faced her final months is an example of this. Even though there were dark times Jasmine's calm acceptance of the challenges of her illness helped her to endure so much with the loving care and support of her sister Lorna. And even though Jasmine's faith was tried with fire she continued to live each moment of her life filled with 'lively hope'. Her quiet dignity and ability to find joy and embrace life each day was an inspiration to all who visited her. This is an edited extract from the address given by the Reverend Helen Kendrick at Jasmine's funeral, which was held in All Saints' Church on 4th August 2015.

Irene Edith Roffey who died, aged 94, on 4th August 2015 was born in Abingdon on 10th December 1920. Shortly after her birth her Mother died and she was adopted within her Mother's family by Walter and Emma Garlick, who had returned from Australia to live back in Sutton Courtenay. She was to spend the rest of her life in this village. She attended the village school and loved recounting the story of the forgetful Vicar - who once posted his gloves through the letterbox by mistake! She enjoyed going to Sunday School every week and later joined the Church Choir. She left school at 14 to go into service and started work at Yarnton Manor, where she lived in during the week and then cycled to Oxford to catch the train with her bicycle to bring her back to Sutton Courtenay. In 1939 she went to work at the Milton Depot as a Transport Clerk – shipping parcels all over the world. Despite it being war time she had a lot of fun during these years with a very active social life. It was during this time that she met John Roffey, a Londoner in the RAF, stationed at Milton Depot. They were married on 20th of June 1941 by the Reverend Scanlan in All Saints' Church, and had a very happy and mutually supportive marriage until his death 20 years ago. Almost immediately after the wedding John was posted oversees for three years until he returned to work in Milton Depot and eventually at Morris Motors. Meanwhile Irene was kept busy looking after the family home in what was then Southend Bungalow. She spent a lot of time looking after the extensive garden and keeping pigs, chickens and rabbits. They grew so much that they often supplied the Mathews family with vegetables to sell in their shop. She was also an active member of the WRVS and would knit clothes for men serving in the armed services. She made one jumper, out of oiled wool for a sailor and included her name and address in the parcel. She was delighted when she received a letter of thanks in return! Peter was born in 1945, followed by Kathleen in 1948. They both remember Irene as a very caring and devoted Mum who looked after them very well - making all their clothes including their school uniforms and cooking delicious meals. They had some wonderful family holidays - caravanning to Beer, the Isle of Wight and coach trips to Hayling Island. Irene always loved to travel and she was very skilled at telling John where to go – he did not have a good sense of direction but fortunately Irene was an excellent navigator. Irene often entertained the extended family and friends - the family have many fond memories of tea in the garden on a summer's afternoon for up to 20 people. She was the longest serving member of the Sutton Courtenay WI and was actively involved in the Mothers' Union and the Women's Christian Fellowship. Later she greatly enjoyed attending the Evergreens Club on a Wednesday afternoon and joining in with the monthly lunches at the Milton Methodist Church. They all loved her cookery skills - and she was affectionately known as Nanny Cakes. She didn't use recipes to cook but did it all by instinct. She always had to make the Christmas Puddings for the family; and the mince pies and the cakes. She even taught her son in law, Graham how to cook and was delighted when he took one of his quiches into the hospital. She was always very stylish – she would have her hair done every Thursday. With the help of her family she remained as independent as she could in her own home until going into hospital where she died. # SUTTON COURTENAY WI



Most of us join the WI to make new friends, learn new skills, visit interesting places and generally have fun.

In 1915 Britain was in the depths of war. Suffragettes had finally won the vote for women and their role was changing: they were needed to boost food production on the home front. The Women's Institute brought friendship and purpose to the lives of its founder members. They started radical campaigning to improve healthcare for women. In 1938 they were successful in bringing pain relief in childbirth to country women. In the 1950s they

campaigned to allow parents to visit sick children in hospital. 1954 saw the Keep Britain Tidy campaign; 1972 free family planning; 1975 screening for breast cancer and cervical cancer. More recent initiatives are SOS for Honeybees, More Midwives and Time to Talk About Organ Donation. Visit this website for more information: thewi.org.uk/campaigns.

During the Second World War when men were away for long periods, women in the countryside not only had to take over the manual jobs on the land but also took evacuee children from the cities into their homes. The WI perhaps won its reputation as jam makers from this time as they were responsible for turning the fruit wasting on the trees and hedgerows into jam and chutney. They were responsible for preserving and canning 5,300 tons of fruit during the war years. They also collected five hundred tons of rosehips for the pharmaceutical industry. They were highly organised and highly praised at government level for their outstanding contribution to the war effort.

It was probably in 1998 when a group of ladies from a Yorkshire WI, supporting a friend at a difficult time, decided to pose for a charity calendar - with a difference! The group aimed to simply buy a new sofa for their local hospice but were so successful that, to date, they have raised over £3million for Leukaemia and Lymphoma Research. They also raised awareness of today's modern organisation - perhaps there is a little more behind this Jam and Jerusalem.

You can find the Oxfordshire Federation of Women's Institutes on Facebook. The WI is also on Twitter. This year the WI were even selling their cakes at Glastonbury!

I have heard ladies say that they will join the WI when they retire, but time is too precious to waste - come along and be inspired! We will be decorating pottery and celebrating our centenary at our September meeting after attending a county service at Christ Church Cathedral. Then on 20 October our speaker is talking about Oxford City in the form of a picture quiz. We also have a trip to a Hindu Temple planned.

# NAG5 SAFETY CORNER

#### <u>Cycle checks at Culham (Sutton) Bridge</u>

The neighbourhood police team patrolled the bridge between Culham and Sutton Courtenay in mid-July. Seven of the twenty three cyclists observed were cycling on the road. The remaining sixteen cyclists were reminded that cycling on the footpath is an offence and told they would be issued with a fixed penalty notice next time. Some cyclists, particularly children and young people, may prefer not to cycle on the road over the bridge for safety reasons. They may dismount and walk, with their bicycle, on the footpath. Random checks on cyclists crossing the bridge will continue.

The following extracts are taken from the Highway Code, Rules for Cyclists (59 to 82). Full details can be found in printed copies of the Highway Code or online by visiting **https://www.gov.uk/rules-for-cyclists-59-to-82**.

- You **MUST NOT** cycle on a pavement.
- Laws HA 1835 sect 72 & R(S)A 1984, sect 129

• You **MUST** obey all traffic signs and traffic light signals.

Laws RTA 1988 sect 36 & TSRGD reg 10(1)

• You **MUST NOT** cross the stop line when the traffic lights are red. Some junctions have an advanced stop line to enable you to wait and position yourself ahead of other traffic (see Rule 178).

- Laws RTA 1988 sect 36 & TSRGD regs 10 & 36(1)
- At night your cycle MUST have white front and red rear lights lit. It MUST also be fitted with a red rear reflector (and amber pedal reflectors, if manufactured after 1/10/85). White front reflectors and spoke reflectors will also help you to be seen. Flashing lights are permitted but it is recommended that cyclists who are riding in areas without street lighting use a steady front lamp.

#### Speed checks in Sutton Courtenay

In mid July neighbourhood police conducted speed checks in Sutton Courtenay. All 34 vehicles observed on Harwell Road were driving within the 30mph speed limit. On Milton Road 4 vehicles out of 31 were over the speed limit. Two of the four vehicles exceeding the speed limit were registered in the name of Sutton Courtenay residents. Random checks will continue to be carried out.

# **COUNTY COUNCILLOR'S REPORT**

#### Austerity...

This is an appeal to all residents for understanding of the very difficult position in which County Officers (not to mention Councillors!) find themselves.

The age of austerity has not been even handed with local government. Cuts in government grants have hit all councils, but New Homes Bonus (the grant awarded to councils for every house they allow to be built) has been split 80% to Districts and only 20% to Counties. Unfortunately, the bulk of the expensive infrastructure that the new houses need (roads, schools and social services) fall on the County Council budget. This imbalance has led to increasingly wealthy District Councils and increasingly cash-strapped County Councils.

Few of us involved in Local government thought that the only decisions we would be making were "What should we cut next to balance the books?". Local government officers have to face often angry and frustrated residents with the only answer they can give – "I'm sorry, we would love to do x and y, but we have no budget for it".

Adjusting the New Homes Bonus split (to say 50:50) would allow the County to save many services – roads, buses, children's centres and so on – services which are at the moment under threat. It would not involve asking government for more money – the money is already there. At the Council meeting on Tuesday 14<sup>th</sup> July, I proposed a motion calling on Central Government to take another look at the way New Homes Bonus is apportioned between Councils. I am delighted to say that it was past unanimously gaining full support even from those councillors who were also District Councillors. No-one wants Districts to be under the same strain as Counties, but until the split is more fairly apportioned, we will be in danger of superb Leisure Centres with gold-plated taps (District responsibilities) which no-one can get to through the potholes and lack of bus services (County responsibilities). We all now need to persuade our MPs to take the message to Westminster before we lose any more vital services in the next budget round.

#### Directing the blame...

In an effort to balance the books, the County has already had to take some tough decisions. One such is the decision to charge for dealing with DIY waste. The County does not have a statutory obligation to provide this service, but has done so for some time now. Recent conversations with staff at the Drayton Waste Collection depot, have exposed the fact that staff have to cope with irate residents who do not think they should be charged. (The fees are very modest and only kick in when more than 3 sacks are being delivered). These disputes happen almost daily. It is certainly not the fault of the staff and I would argue (although as an Opposition Councillor I don't have to!) that it is not the fault of the council. In May the country voted for austerity, and the need to charge for non-statutory services is what austerity brings with it.

In the coming weeks, the Council will be consulting on its plans to cut Children's Centres and Early Intervention Hubs. It is inevitable that there will be much anger at the potential loss of a major universal service particularly valued by many hard-pressed families. The Council is trying to cope with a budget cut in this area of 50% whilst trying to continue to provide a service to the most vulnerable families in the County. The County Officers do not want to have to do it. The County Councillors do not want to have to do it. It is being done as a result of national austerity policy. Right or wrong it is a national issue and there is little local government can do about it.

## ED VAIZEY MP

Like myself many of you may have enjoyed a trip to the cinema on a rainy day during the school summer holidays, so I was very interested to be told by the British Film Institute that they have opened a new round of funding for the <u>BFI Neighbourhood Cinema Equipment Fund</u>. Any community cinemas that have been running for 6 months or more and have set up a profile on the <u>BFI Neighbourhood Cinema</u> website are eligible to apply for National Lottery funding to pay for projectors, screens, DVD players, also chairs and black out blinds. Communities that already have film clubs or village hall cinemas have until 28 September to apply. All you need to do is check your eligibility. If you need to start from scratch, then you will have to apply for the next round of funding in a few months. In the meantime you should watch the <u>BFI Neighbourhood Cinema film</u> and take a look at their <u>organisations that support you</u> so that you are ready for your application.

The British Film Institute set up this scheme to bring big screen experiences and a wider choice of specialised and independent British films to people in communities across the UK. To date they have awarded £362,000 to 96 community schemes across the UK and their aim is to allow everybody in the UK to see and enjoy a wide range of films in a shared cinema experience, no matter where they live and help bring local communities closer together.

On the other side of the screen the BBC have launched their Make it Digital Traineeship which will be available in around 60 towns and cities in England. The BBC Academy and partners the Department of Work and Pensions (DWP) and Skills Funding Agency (SFA) are calling on 16-24 year olds who are unemployed, have fewer than two A Levels and an interest in developing their digital skills, to register their interest via their local Jobcentre Plus. The Jobcentre Plus network will then play a crucial role in identifying suitable candidates, who will be invited to take part by their Jobcentre Work Coaches. Training will be delivered by high-quality local training providers across the country followed by structured work placements with local employers. This month's postbag has been dominated by letters and emails on the upcoming parliamentary bill on assisted suicide. I have no moral objection to a law that would assist someone to die – provided they were of course making a decision entirely of their own free will, and based on their circumstances. However, my very real concern has been and always will be what one might call "the thin end of the wedge". For every person that we might consider to have a clear and settled wish to end their lives, there are countless others who are vulnerable, despairing and often lacking in support who may feel under pressure to go through with this decision. Would we, in effect be encouraging those who might not otherwise have done so to decide to take their own life? This Bill legitimises the idea that suicide is a solution for disability and severe sickness. But, as years of debate on this issue in the House of Lords has shown, there is no safeguard that would be sufficient to stop a person who feels a burden on their caregivers from ending their life; nor can doctors accurately assess this, or worse, pressure or abuse which does regrettably exist in certain cases. This is why none of the Royal Medical Colleges support a change in the law. In fact, the British Medical Association, the Royal College of GPs and the Royal College of Physicians, actively oppose such a change for that very reason. As evidence from other countries has shown, a right to die would for many be a duty to die. This is a matter of conscience, and as such, will be decided by a free vote. For the reasons set out above, we must fiercely resist this bill.

For the cake: 100g/4oz soft butter, 100g/4oz castor sugar, 100g/4oz self-raising flour, 2 large eggs, 1 tsp baking powder,50g/2oz chopped walnuts, 1 tbsp coffee essence.

For the filling and topping: 75g/3oz butter, softened,

225g/8oz icing sugar, sifted, 2 tsp milk, 2 tsp coffee essence, 8 walnut halves, to decorate.

Preheat oven to 180C/350F/Gas 4. Grease and line the bases of two 18cm/7in diameter sandwich tins. Beat together all the cake ingredients in a large bowl until well combined and smooth. Divide the mixture between the cake tins and bake for 20-25 minutes. Allow to stand for five minutes before turning onto a wire rack to cool. For the filling and topping, beat the butter and gradually add the icing sugar. When all is added, add the milk and coffee essence and beat until smooth. Spread half the coffee icing on one cake and sandwich together with the other half. Ice the top of the cake with the remaining coffee icing and decorate with walnut pieces.

YOUTH & COMMUNITY ACTING TOGETHER An Abingdon DAMASCUS Youth Project initiative

The youth project offers life-changing support to several young people in the village and also benefits the wider community as it is rooted within the communities it serves. Increasing inter-generational cohesion and responsibility within the community is at the heart of all its work with young people.

In the past three years young people have been key to the organisation of events that have raised significant funds for the refurbishment of the recreation ground and the War Memorial and funds for the Church and the village school. They have organised senior citizens' tea parties, litter picks and inter-generational quizzes.

The youth project was set up in 1999 and became a registered charity in 2003 largely due to the efforts of the late Ian Spalding (our first chairman). It has always been the community's project and at the time it was set up the main issues were around anti-social behaviour which was invariably associated with young people. The situation is still monitored as young people are more mobile and we do get young people visiting from neighbouring towns.

From our on-the-streets' analysis, a significant issue in our village today is about the increasing susceptibility of young people to negative peer pressures and risky behaviours as result of exposure and easy access to social media and inappropriate internet sites. This has also had an adverse impact on peer-to-peer relationships.

Building non-judgemental but enabling relationships is crucial to making a difference to young people's lives and their communities. Gary, Roxy, Holly and Daniel have worked tirelessly at evenings, weekends, bank holidays to make that difference.

You may recall from earlier articles that the youth project came to the end of its 5-year lottery grant of £35,000 per year in November 2014. There is every intention of applying for further grants. However, the process is extremely competitive. The more we can demonstrate local support by the way of fundraising, the stronger our likelihood of success.

A huge thanks once again to all who support the work of the project in so many different ways. Thank you also to The Swan, The Plough, The Fish, Changes, Richard Matthews, and Deepak Patel for their support in fund raising events.
